

# The Bonus Dining Scheme



The Bonus Dining Scheme gives you more freedom to eat what you want, when you want. Simply buy one of the cards and top it up to start enjoying the discounts that the card has to offer. The card will cost you £50, which will give you 50 units to spend (£1 is equal to 1 unit) but you can put on as much or as little over that as you like. Top up over £100 and we will give you an extra 10% in units.

The card is accepted in both Barker House Farm and Café Twenty Ten and can be used to treat you, a guest or friend. It will work like a debit card but with the added bonus of there being special discounted meals available daily for you to try. Top ups can be made at Café Twenty Ten.

If you are part of catered accommodation you can also benefit from the Bonus Dining Card as the card can be used at times when catered accommodation isn't available, such as lunch times or outside of the usual catered accommodation eating times.

Getting yourself signed up for the scheme couldn't be easier. Simply come into Café Twenty Ten, the Venue, the Hub, Café21 or Barker House Farm and pick up a form, or fill in the form attached and return to Café Twenty Ten.

## Terms and Conditions:

Please read the terms and conditions below carefully before applying for the scheme.

1. The right to use this service may be revoked or suspended by the Hospitality Division Management without notice should you materially breach any of these terms and conditions. In such cases refund will be paid as per the refund criteria within this agreement.
2. The card is for use in named University Facilities only.
3. In the event that an account cannot be processed on first presentation, the service will be withdrawn and you will be required to re-apply.
4. A handling charge of 6% for overseas transactions will apply. Cash, cheques and debit cards will attract no handling fee.
5. Alcohol can only be provided with a substantive plated meal in licensed restaurants.
6. The management reserve the right to refuse service.
7. The management may alter times of opening, displayed menus and terms of agreement without prior written notice.
8. The customer can use their card whilst they are a student of Lancaster University.
9. If the dining card does not meet your needs, you are entitled to a refund. Refunds are calculated as total funds on your card less £50 administration fee. The refund will be paid back to the original cardholder.
